9 A YES. HE WAS A CAR BROKER OR SOME SORT OF THING LIKE THAT.

10 Q DURING THE COURSE OF YOUR DEALINGS WITH MR. GRACIA,
11 MR. WILLIAMS, DID YOU MEET VIRGINIA HIGH?

12 A YES, I DID.

13 Q WOULD YOU TELL US THE CIRCUMSTANCES?

14 A WE WENT OVER TO THE HIGH'S HOUSE TO MAKE A PAYMENT OF
15 \$1,600 FROM MR. GRACIA'S HOUSE ON CASCADE ROAD.

16 Q THE MONEY, WERE YOU PRESENT WHEN THE MONEY WAS
17 TRANSFERRED?

18 A YES, I WAS.

19 Q WHAT FORM DID THIS MONEY TAKE?

20 A WE WENT INTO THE DINING ROOM AREA IN WHICH WE SAT AT A
21 TABLE. AT THAT TIME HE JUST HANDED IT HAND TO HAND TO HER.

22 Q AGAIN, LET ME ASK YOU, WHAT FORM DID THE FUNDS TAKE,
23 CHECKS, CASH, WHAT?

24 A SIR, IT WAS CASH.

25 Q MR. WILLIAMS, DID THERE COME A POINT IN TIME IN YOUR

1 DEALINGS WITH MR. GRACIA WHEN YOU CAME TO KNOW A PERSON BY THE
2 NAME OF DAVID WALLACE?

3 A YES, I DID.

4 Q HOW DID YOU MEET MR. WALLACE?

5 A ME AND MR. WALLACE HAD ALREADY KNOWN EACH OTHER FOR A
6 COUPLE OF YEARS, BUT THROUGH MR. GRACIA WE MET AT A TABLE IN
7 HOUSTON'S RESTAURANT.

8 Q IN THE -- HOW OFTEN DID YOU SEE MR. WALLACE AND MR. GRACIA
9 TOGETHER?

10 A WELL, BEFORE I EVEN JOINED THE ORGANIZATION WITH
11 MR. GRACIA, I SEEN HIM AND MR. WALLACE TOGETHER AT NIGHTCLUBS
12 AND AREA ADULT ENTERTAINMENT CLUBS.

13 Q DID MR. GRACIA EVER TELL YOU WHAT THE RELATIONSHIP WAS
14 THAT HE HAD WITH MR. WALLACE?

15 A YES, HE DID. ONE TIME HE WAS BRAGGING INSIDE OF MAGIC
16 CITY IN WHICH HE TOLD ME THAT DAVID WALLACE WAS A DISTRIBUTOR
17 FOR HIM.

18 Q DID YOU IN THE COURSE OF YOUR DEALINGS WITH MR. GRACIA OR
19 OTHERWISE MEET A MAN BY THE NAME OF BUBBA?

20 A YES, I DID.

21 Q TELL US ABOUT, HOW DID YOU MEET BUBBA?

22 A PRIMARILY I KNOW BUBBA THROUGH NUMEROUS YEARS, BUT I MET
23 HIM THROUGH THE DISTRIBUTION OF COCAINE.

24 Q DID YOU EVER SEE BUBBA WITH MR. GRACIA?

25 A NO, I DID NOT.

1 Q DID YOU SELL COCAINE TO BUBBA?

2 A YES, I DID.

3 Q ABOUT HOW MANY TIMES, DO YOU RECALL?

4 A IT WAS NUMEROUS TIMES, SIR.

5 Q WHAT QUANTITIES DID YOU SELL TO HIM?

6 A FIVE TO SEVEN KILOS OF COCAINE ON NUMEROUS OCCASIONS.

7 MR. MOYE: MAY I HAVE JUST A MOMENT, YOUR HONOR?

8 THE COURT: ALL RIGHT.

9 Q MR. WILLIAMS, IN THE HOUSE THAT YOU HAVE DESCRIBED AS THE
10 DELIVERY HOUSE, THE HOUSE DEPICTED IN GOVERNMENT EXHIBIT 112,
11 DID YOU EVER GO ANYWHERE BESIDE THE GARAGE IN THAT HOUSE?

12 A YES.

13 Q IN THAT HOUSE WAS THERE ANY FORM OF A SAFE?

14 A I BELIEVE SO. I NEVER SAW IT.

15 Q YOU NEVER SAW IT.

16 MR. MOYE: THANK YOU, SIR.

17 I HAVE NO FURTHER QUESTIONS, YOUR HONOR, OF

18 MR. WILLIAMS.

19 THE COURT: MR. MORRISON, DO YOU HAVE ANY QUESTIONS?

20 MR. MORRISON: I DO, JUST A FEW.

21 THE COURT: ALL RIGHT.

22 CROSS-EXAMINATION

23 BY MR. MORRISON:

24 Q MR. WILLIAMS?

25 A YES, SIR.

- 1 Q DO YOU KNOW AN INDIVIDUAL BY THE NAME OF ROBERT BURROUGHS?
- 2 A ROBERT BURROUGHS?
- 3 Q YES.
- 4 A NO, I DO NOT.
- 5 Q AN INDIVIDUAL BY THE NAME OF MILTON MCDONALD?
- 6 A NO, I DO NOT.
- 7 Q DO YOU KNOW GEORGE HIGH?
- 8 A NO, I DO NOT.
- 9 Q NOW, YOU DESCRIBED A WHITE PERSON, WHAT WAS THAT PERSON'S
- 10 NAME?
- 11 A AT THAT TIME, IT HAS BEEN TWO YEARS, SO I BELIEVE IT WAS
- 12 STEVE OR KYLE.
- 13 Q AND WHAT DID THAT PERSON DO?
- 14 A AT THAT TIME HE SOLD A Q-45 INFINITI FOR MR. GRACIA.
- 15 Q WHO?
- 16 A I DO NOT KNOW.
- 17 Q WHERE WERE YOU WHEN YOU MET HIM?
- 18 A IT WAS A SPORTS BAR AND GRILL. I THINK IT WAS IN THE COBB
- 19 AREA.
- 20 Q WERE YOU PRESENT WHENEVER THIS INDIVIDUAL SPOKE WITH
- 21 MR. GRACIA?
- 22 A YES, I WAS.
- 23 Q AND TELL ME WHAT THEIR CONVERSATION WAS?
- 24 A BASICALLY THE CONVERSATION WAS ABOUT THE CARS AND ABOUT
- 25 SELLING OF OTHER CARS THAT MR. GRACIA HAD THAT HE WANTED TO GET

1 RID OF.

2 Q NOW, WHEN -- WERE YOU AWARE OF HOW MR. GRACIA KNEW THIS
3 PERSON?

4 A NO, I AM NOT.

5 Q WHEN HE MET WITH HIM AT THE SPORTS BAR AND GRILL, DID
6 MR. GRACIA TELL THIS PERSON THAT HE WAS A DRUG DEALER AND THAT
7 HE WANTED TO BUY A CAR?

8 A NO, HE DID NOT.

9 Q NOW, APPROXIMATELY ACCORDING TO YOUR TESTIMONY, HOW LONG
10 DID YOU KNOW MR. GRACIA?

11 A FOR A NUMBER OF YEARS, SINCE 1987.

12 Q AND ACCORDING TO YOUR TESTIMONY THERE CAME A TIME WHEN YOU
13 CAME TO ATLANTA AND ACCORDING TO YOUR TESTIMONY YOU ENTERED
14 INTO WHAT YOU REFER TO AS THE DRUG INDUSTRY?

15 A YES.

16 Q CORRECT?

17 AND PART OF THAT WAS WITH MR. GRACIA?

18 A YES, IT WAS.

19 Q AND YOU SAID THAT YOU WERE AT HIS HOUSE APPROXIMATELY,
20 WHAT, 30 OR 40 TIMES?

21 A SIR, I DON'T HAVE A NUMBER OF HOW MANY TIMES I VISITED
22 MR. GRACIA'S HOUSE BUT IT WAS NUMEROUS TIMES.

23 Q DURING THE PERIOD OF TIME WHERE YOU SAY THAT YOU WERE
24 WORKING WITH MR. GRACIA, WERE YOU WITH HIM OR DID YOU SEE HIM
25 ON A REGULAR BASIS?

- 1 A YES, I DID.
- 2 Q WOULD YOU SAY DAILY?
- 3 A YES. YES, I WOULD.
- 4 Q WOULD IT BE UNUSUAL FOR THERE TO BE TWO OR THREE DAYS
5 WHERE YOU DIDN'T SEE HIM?
- 6 A YES, IT WOULD.
- 7 Q AND I TAKE IT THAT YOU SAW HIM NOT ONLY AT HIS HOUSE BUT
8 YOU SAW HIM AT OTHER LOCATIONS?
- 9 A YES, I WOULD.
- 10 Q DID YOU RIDE AROUND WITH HIM IN A CAR?
- 11 A YES, I WOULD.
- 12 Q OTHER THAN THIS ONE TIME THAT YOU WENT TO THE PLACE WHERE
13 YOU SAY THAT YOU MET VIRGINIA HIGH, DID YOU GO WITH HIM TO ANY
14 OTHER PLACES, RESTAURANTS?
- 15 A YES, I WOULD.
- 16 Q CAR DEALERSHIPS?
- 17 A NO CAR DEALERSHIPS, ONLY RESTAURANTS AND ENTERTAINMENT AND
18 ENTERTAINMENT EVENTS.
- 19 Q WOULD YOU SAY THAT YOU KNEW WHO HIS PERSONAL FRIENDS WERE?
- 20 A NO, I CANNOT SAY THAT.
- 21 Q DID YOU KNOW SOME OF THEM?
- 22 A APPROXIMATELY I DID.
- 23 Q OKAY. AND ACCORDING TO YOUR TESTIMONY, YOU DON'T KNOW
24 THAT -- YOU DON'T KNOW GEORGE HIGH TO BE IN THAT GROUP, DO YOU?
- 25 A NO, I DON'T.
