ORDER

On July 22, 1992, this Court signed the warrant above-styled, authorizing the search of the premises listed hereinabove. That warrant has not yet been executed. The Court enters this order with the intent to make explicit what was implicit in the warrant, to wit: the items which the warrant authorizes the agents executing the same to seize.

A copy of this order shall be affixed to the warrant, and incorporated therein, as if the same had been included in the warrant as originally issued.


Included in the affidavit, signed before this Court on July 22, 1992, by S/A W.J. Salinski, Internal Revenue Service, was the following listing of items to be seized:

- a. Books, records, receipts, notes, ledgers, bank statements and bank records, money drafts, letters of credit, money order checks, U.S. currency and other items evidencing the obtaining, secreting, transfer and/or concealment and/or expenditure of money.
- b. Deeds, contracts, notes, closing statements and other evidence of real property transactions involved in the laundering of illegal income.
- c. Photographs of co-conspirators, indicted properties and other properties known to be owned, occupied or controlled by co-conspirators.

- d. Computer hardware and/or software used to store and maintain information relating to money laundering activities.
- e. Records relating to storage facilities, safe deposit boxes and other locations where assets and/or records may be secreted. This includes, but is not limited to, documents and keys to such locations.

The Court incorporates that list into the warrant, and specifically authorizes the agents to seize those items.
