2 MR. MOYE: CALL SPECIAL AGENT CHARLES BOYD.

3 CHARLES BOYD,

4 BEING FIRST DULY SWORN, WAS EXAMINED AND TESTIFIED AS FOLLOWS:

5 THE CLERK: BE SEATED, PLEASE, AND STATE YOUR NAME
6 FOR THE RECORD.

7 THE WITNESS: MY NAME IS CHARLES BOYD.

8 DIRECT EXAMINATION

9 BY MR. MOYE:

10 Q. MR. BOYD, WOULD YOU SPELL YOUR LAST NAME FOR THE COURT
11 REPORTER?

12 A. B-O-Y-D.

13 Q. MR. BOYD, HOW ARE YOU EMPLOYED, SIR?

14 A. SIR, I AM CURRENTLY EMPLOYED AS A SPECIAL AGENT WITH THE
15 GEORGIA BUREAU OF INVESTIGATION, DETACHED TO THE F.B.I..

16 Q. AND MR. BOYD, HAVE YOU AS PART OF YOUR RESPONSIBILITIES
17 WITH THE G.B.I., DETACHED TO THE F.B.I., PARTICIPATED IN THE
18 INVESTIGATION OF ALEX GRACIA AND OTHERS?

19 A. YES, SIR, I HAVE.

20 Q. DID THERE COME A TIME IN OCTOBER OF 1990 WHEN YOU MET MR.
21 WALTER WILSON?

22 A. YES, SIR.

23 Q. CAN YOU TELL US WHERE IT WAS THAT YOU FIRST CAME INTO
24 CONTACT WITH MR. WILSON?

25 A. IN SOUTHWEST ATLANTA IN THE REAR OF A CHURCH OFF OF

1 CASCADE ROAD.

2 Q. HOW DID YOU COME IN CONTACT WITH HIM OR ARRANGE TO MAKE
3 CONTACT WITH HIM?

4 A. I WAS ASSIGNED TO SURVEILL A RESIDENCE ON GREENWOOD LANE,
5 SOUTHWEST ATLANTA, AS PART OF THAT ASSIGNMENT I WAS MAKING AN
6 EFFORT TO IDENTIFY WHICH AGENCY, SANITATION AGENCY WAS
7 RESPONSIBLE FOR COLLECTING THE TRASH FROM A RESIDENCE THERE.
8 ONCE IT WAS DETERMINED THAT A PRIVATE ENTITY WAS COLLECTING THE
9 TRASH, I THEN SPOKE WITH THE SUPERVISOR, IDENTIFIED MYSELF AND
10 INDICATED THAT I NEEDED ASSISTANCE FROM THE ROUTE PERSON FOR
11 THAT PARTICULAR AREA.

12 Q. WAS ASSISTANCE MADE AVAILABLE TO YOU AND TO THE OTHER
13 AGENTS WORKING ON THE INVESTIGATION?

14 A. IT WAS, SIR.

15 Q. AND DO YOU RECALL OVER WHAT PERIOD OF TIME THIS ASSISTANCE
16 WAS PROVIDED?

17 A. APPROXIMATELY A YEAR AND A HALF TO TWO YEARS.

18 Q. MR. BOYD, TELL US, IF YOU WOULD, WHAT ASSISTANCE
19 SPECIFICALLY YOU REQUESTED OF THIS ROUTEMAN?

20 A. I REQUESTED THAT GARBAGE FROM 740 GREENWOOD LANE BE
21 SEGREGATED AND BROUGHT TO ME FOR MY INSPECTION.

22 Q. AND THE PERSON YOU MADE THIS REQUEST OF, WAS THAT MR.
23 WILSON?

24 A. THAT IS CORRECT.

25 Q. AND DID YOU AND HE SET UP SOME METHOD BY WHICH YOU WOULD

1 RECEIVE THIS GARBAGE THAT HE HAD SEGREGATED?

2 A. THAT IS CORRECT.

3 Q. AND WHAT SYSTEM DID YOU SET UP?

4 A. MR. WILSON INFORMED ME OF THE DAYS HE WOULD COLLECT
5 GARBAGE FROM GREENWOOD LANE AND THE TIME. IT WAS THEN
6 SUGGESTED BY MR. WILSON THAT AT AN APPROPRIATE OR AN APPOINTED
7 TIME I WOULD BE IN THE REAR OF THE CHURCH TO MEET HIM TO
8 COLLECT GARBAGE. AND IF THERE WAS NO GARBAGE, MR. WILSON WOULD
9 NOTIFY G.B.I. COMMUNICATIONS FOR ME TO NOT COME TO THAT AREA ON
10 THAT PARTICULAR DAY.

11 Q. HOW FAR FROM GREENWOOD WOULD THIS BE WHERE YOU WOULD MEET
12 MR. WILSON ON THOSE DAYS YOU DID MEET HIM?

13 A. APPROXIMATELY THREE-QUARTERS OF A MILE.

14 Q. WHEN YOU MET MR. WILSON ON THESE OCCASIONS, WHAT DID YOU
15 RECEIVE?

16 A. PLASTIC GARBAGE BAG OR PLASTIC BAG CONTAINING GARBAGE.

17 Q. THE GARBAGE, WOULD THERE BE OLD FOOD IN THE GARBAGE BAGS?

18 A. YES, SIR. AS WELL AS OTHER REFUSE TO INCLUDE CARPET
19 FRESHENER, AS WELL AS CORRESPONDENCE, ENVELOPES.

20 Q. LET ME SHOW YOU -- LET ME FIRST ASK YOU, MR. BOYD, IF YOU
21 RECALL MEETING MR. WILSON ON NOVEMBER 2ND, 1990?

22 A. YES, SIR, I BELIEVE.

23 Q. LET ME ASK YOU (IF ON THAT DAY YOU RECEIVED TRASH?

24 A. I DID, SIR.

25 Q. LET ME HAND YOU WHAT I MARKED FOR IDENTIFICATION AS

1 GOVERNMENT EXHIBIT 165, AND ASK YOU IF YOU RECOGNIZE THIS ITEM?

2 A. YES, SIR.

3 Q. DO YOU RECALL RECEIVING THAT FROM SOMEONE?

4 A. I DO, SIR.

5 Q. WHO DID YOU RECEIVE THAT FROM?

6 A. FROM WALTER WILSON.

7 Q. LET ME SHOW YOU GOVERNMENT EXHIBIT 166, AND DIRECT YOUR
8 ATTENTION TO JANUARY 4TH, 1991, AND ASK YOU, SIR, IF YOU
9 RECEIVED THAT ITEM ON THAT DATE?

10 A. I DID, SIR.

11 Q. AND FROM WHOM DID YOU RECEIVE GOVERNMENT'S 166?

12 A. WALTER WILSON, SIR.

13 Q. I DIRECT YOUR ATTENTION TO FEBRUARY 1ST, 1991, AND ASK
14 YOU, SIR, IF ON THAT DAY YOU MET MR. WILSON?

15 A. I DID, SIR.

16 Q. I HAND YOU GOVERNMENT EXHIBIT 167, AND ASK YOU, SIR, IF
17 YOU RECOGNIZE THAT?

18 A. YES, SIR, I DO.

19 Q. AND FROM WHOM DID YOU RECEIVE THAT?

20 A. WALTER WILSON, SIR.

21 Q. LET ME DIRECT YOUR ATTENTION TO MARCH THE 5TH, 1991, AND
22 ASK YOU, SIR, IF ON THAT DAY YOU MET MR. WILSON?

23 A. I DID, SIR.

24 Q. I HAND YOU GOVERNMENT EXHIBIT 168-A AND B, AND ASK YOU IF
25 YOU RECOGNIZE THOSE ITEMS?

1 A. I DO, SIR.

2 Q. AND FROM WHOM DID YOU RECEIVE THOSE?

3 A. WALTER WILSON, SIR.

4 MR. MOYE: YOUR HONOR, I TENDER 165, 66, 67, AND
5 168-A AND B.

6 MR. MORRISON: COULD I SEE THOSE ONE MINUTE?

7 THE COURT: ALL RIGHT. TAKE A LOOK AT IT.

8 ANYBODY HAVE ANY --

9 MR. ROSEN: WHAT WAS THE DATE OF GOVERNMENT EXHIBIT
10 166?

11 THE COURT: 4TH OF JANUARY.

12 MR. ROSEN: THANK YOU.

13 THE COURT: ANYBODY HAVE ANY OBJECTION?

14 MR. MORRISON: NO OBJECTION.

15 MR. ROSEN: NO OBJECTION.

16 THE COURT: LET THEM IN.

17 BY MR. MOYE:

18 Q. MR. BOYD, GOVERNMENT EXHIBIT NO. 165 INCLUDES -- WHAT IS
19 THAT DOCUMENT?

20 A. SIR, THIS IS AN INVITATION FROM THE IMPERIAL PALACE, LAS
21 VEGAS, NEVADA.

22 Q. IS THERE A DATE ON THE INVITATION?

23 A. IF IS.

24 Q. WHAT IS IT?

25 A. OCTOBER THE 25TH, 1990.

1 Q. CAN YOU TELL US WHAT THE INVITATION WAS TO?

2 A. YES, SIR, BIRTHDAY CELEBRATION FOR GUS GRIGGS AND SAM
3 CARROLL AT THE ROYAL HALL A AND B, THIRD FLOOR, IMPERIAL
4 PALACE, LAS VEGAS, NEVADA. IT'S IN REFERENCE TO A HEAVY WEIGHT
5 AFTER-PARTY FIGHT, EVANDER HOLYFIELD.

6 Q. I HAND YOU GOVERNMENT'S 166, AND ASK YOU WHAT THAT IS?

7 A. WHITE ENVELOPE BEARING THE NAME LAS VEGAS HILTON, SHOW
8 CASE, ADDRESSED TO ALEXANDER, MIDDLE INITIAL D AS IN DAVID,
9 GRANT.

10 Q. WHAT ADDRESS?

11 A. 2037 REBECCA LANE, DECATUR, GEORGIA.

12 Q. I HAND YOU GOVERNMENT EXHIBIT 167, AND ASK YOU, SIR, WHAT
13 THAT THIS?

14 A. WHITE ENVELOPE, SIR, WITH WRITINGS AND PHONE NUMBERS.

15 Q. I HAND YOU GOVERNMENT EXHIBIT 168-B, AND ASK YOU, SIR,
16 WHAT THAT IS?

17 A. APPEARS TO BE A HANDBILL FROM ALSTON PLACE, TOWNHOUSE ON
18 LENOX, ADDRESS 2970 LENOX ROAD.

19 Q. AND GOVERNMENT EXHIBIT 168-A IS WHAT?

20 A. SIR, A WHITE PIECE OF PAPER WITH WRITINGS.

21 MR. MOYE: THANK YOU, MR. BOYD.

22 YOUR HONOR, I BELIEVE THOSE ARE ALL MY QUESTIONS ON
23 DIRECT EXAMINATION.

24 THE COURT: MR. MORRISON?

25 CROSS-EXAMINATION
